




Brief Specification : (F - Type)

1. Structure : RCC framed structure on RCC pile foundation with brick walls.

2. Finishes:

- a) Vitrified & Ceramic tiled flooring in Living cum Dining hall and Bed rooms.
- b) **Kitchen :** Granite counter top. Ceramic tiles on dado and floor.
- c) **Toilets**: Anti-skid ceramic tiles on floors and Ceramic tiles on walls upto lintel level.
- d) **Wall finishes :** (i) Interior-Smooth finish with Plaster of Paris and Acrylic primer. (ii) Exterior-Painting with external acrylic emulsion.
- e) **Door/Windows**: Flush door, wooden door frame and fully glazed Aluminium windows with MS grill. Door in between Living Dining & Verandah Fully Glazed Aluminium.
- f) Internal electrification : Fully Concealed Copper conductor wiring with modular switches and adequate arrangements for installing modern gadgets of standard quality.

There are provisions for internal electrification for each dwelling unit and the allottees shall have to make their own arrangements for connection from CESC Ltd. for individual units and of other common facilities.				
Sewerage	: Sewer lines have been laid and connected to each flat. The Sewage will be disposed of through the system of Kolkata Municipal Corporation. Kitchen waste water and storm water will be discharged through the surface drain. Sewerage and drainage outside the complex will be maintained by Kolkata Municipal Corporation, whereas sewerage and drainage system inside the complex will be maintained by the association formed by the allotees.

Pump room with two (02) nos. Centrifugal pumps with necessary panels, Electrical meter room, Security room, Lift 3 nos. (Passenger lift), area light with underground cable system and General illumination, submersible pumps with panel.
